REPORT PREPARED BY THE BOARD OF DIRECTORS OF "VISCOFAN, SOCIEDAD ANÓNIMA" RELATED TO THE RE-ELECTION OF ÁGATHA ECHEVARRÍA CANALES AS A DIRECTOR CLASSIFIED AS "OTHER EXTERNAL DIRECTORS" THAT IT PROPOSES TO THE GENERAL SHAREHOLDERS' MEETING CALLED FOR 24 AND 25 MAY 2018.

A) PURPOSE OF THE REPORT

Article 529i of the Corporate Enterprises Act, as amended by Law 31/2014, of 3 December, establishes that:

"4. The proposal for the appointment or re-election of the members of the Board of Directors is made by the Appointments and Remuneration Committee, in the case of independent Directors, and by the Board itself, in other cases.

5. The proposal must in any case be accompanied by a report from the Board assessing the competence, experience and merits of the proposed candidate, which must be attached to the minutes of the General Shareholders' Meeting or the Board itself.

6. The proposal for the appointment or re-election of any non-independent Director must also be preceded by a report from the Appointments and Remuneration Committee. [..]"

In order to comply with the provisions of section 5 of the aforementioned article, the Board of Directors of VISCOFAN S.A. has prepared this report, which accompanies the proposal for the re-election of Ágatha Echevarria Canales as a member of the Company's Board of Directors, as "other external Director", which is submitted to the Company's Annual General Shareholders' Meeting.

For the purposes of making the aforementioned proposal, the Board of Directors has assessed the report of the Appointments and Remuneration Committee, in accordance with the provisions of section 6 of article 529i, that it makes its own in its entirety.
